Tel Aviv, Israel – May 29, 2019 - Bezeq The Israel Telecommunication Corp., Ltd. (TASE: BEZQ), announced a further update to its earlier reports regarding a request to approve a class action against its subsidiary, Pelephone Communications Ltd. ("Pelephone"), as filed in the Tel Aviv District Court. The matter concerns an alleged harassment (repeated telephone calls aimed at recruiting customers) that Pelephone participated in.
